The two thousand four hundred and thirty-second meeting of the Jennings City Council was held on Wednesday, April 13, 2022 at 5:00 p.m. via Zoom Video.

A. SPECIAL MEETING

1. **Call to Order** - The meeting was called to order at 5:00 p.m.

2. **Roll Call: Council members present:** Allan Stichnote, Yolonda Fountain Henderson, Terry Wilson, Jane Brown, Gary Johnson, Joseph Turner; none absent

Rose Eichelberger arrived at 5:04 and Lorraine Clower arrived at 5:12.

Also present: Mayor Yolanda Austin; Deletra Hudson, City Clerk.

B. CLOSED SESSION, PERSONNEL (RSMO 610:021-3)

On the motion made by Councilman Wilson, seconded by Councilwoman Fountain Henderson, the City Council approved a closed session for personnel (RSMO 610:021-3) by the following roll call vote of councilmembers voting in favor: Stichnote, Fountain Henderson, Wilson, Brown, Eichelberger, Johnson, Turner; Clower absent.

1. PERSONNEL - The following actions were taken:

a. Hiring of Full Time Correctional Officers

b. Termination of Full Time Public Works Laborer
