Presentation of Petitioners, Remonstrations, Complaints, and Request

I. Presentation from St. Louis County Police Department
Captain Cox reviewed Ordinance 2116, on Decorum, during the Council meeting. Captain Cox responded to a comment from last month asking, "what do we do exactly". He reported that the, St. Louis County Police Department has answered 2,072 radio calls and made 275 arrest in the Jennings area over the last He described shootings where nothing has been impacted. Captain Cox advised that there is a big problem with weapon offenses and the polices job is to catch the people and bring them to justice. He said, that the Crimes Against Persons Unit has solved 4 of the 6 homicides that have taken place in Jennings this year. month. He described a recent arrest made in the area. Captain Cox reviewed what happens with the Drug the Drug Unit is one of the two specialized units in Jennings that he feels best supplements what the St. Louis County Police Department already does. Captain Cox stated that there is a huge drug problem in Jennings. He reviewed the crime statistics and said that from last year crime is up 11% in part one crime. He described the comparison between the part one crime numbers between 2015, 2016, 2017, and the current year. He said, that the biggest problems are burglaries and violent offenses involving hand guns. Units and the need for residents to continue to call when they see drug activity happening.
