The two thousand three hundred sixty first meeting of the Jennings City Council was held on Thursday, April 13, 2017 at 5 p.m. at Jennings City Hall.

3) **NEW BUSINESS:**


A. City Hall Holiday Closing

Mayor Pro Tem Dugger opened the meeting discussing with the Council a resolution regarding employees' holiday. She informed the Council that there were some discrepancies on what was printed and posted as a 2017 holiday schedule versus what was approved in a 2011 holiday resolution. She asked for a motion to amend the resolution. Councilwoman Jones recommended that the Council make a motion to only address the employees having time off on Good Friday, April 14, 2017. She suggested revising the resolution in the Policy Committee Meeting.


Mayor Pro Tem Dugger stated that the resolution and the 2017 holiday schedule are similar with the exception of the 2017 holiday schedule listing Good Friday as a day for employees to work until noon, the resolution doesn't address Good Friday as a holiday for City employees.

Councilman Stichnote made a motion for staff to have the entire day off on Good Friday, April 14, 2017, Councilwoman Dugger seconded the motion. On the question, council discussed whether to amend the motion to include revising the resolution to include Good Friday as an official City holiday. The determination was to only address the Good Friday, April 14, 2017 and allow the new Mayor and Council to determine any changes to the resolution. On the roll call voting in favor were the following Councilmembers Stichnote, Jones, Dugger, Fortson, Anderson, Cook, R. Epps, C. Epps; no one voting against or abstaining.

The meeting was adjourned on a motion by Councilwoman Jones, seconded by Councilwoman Anderson at 5:26 pm.
