**Joint Committee Meeting with the Ways & Means and Public Safety Committee and the Public Works and Building Committee**

**Via Teleconference @ 5:00 p.m.**

The Ways and Means and Public Safety Committee shall have jurisdiction for the purpose of investigation and reporting to the city council all matters pertaining to revenues, public debt, interest, appropriations, disbursements, retrenchment and all other matters not properly referable to other committees. All bills, claims and accounts against the city shall be presented to, and reported on, by this committee. Additionally, the committee shall have accountability and jurisdiction for the purpose of reviewing a police service agreement by and between the City of Jennings and the police department and investigate all matters pertaining to the administration and operation of the correctional department and facilities, as well as any public safety matters. The Public Works and Building committee shall have jurisdiction for the purpose of investigation and reporting to the city council all matters pertaining to streets, sewers, solid waste, public utilities, public health, public charity, public improvements and betterment of conditions. Additionally, the committee shall have jurisdiction for the purpose of investigation and reporting to the city council all matters pertaining to the construction, maintenance and repairs of all public buildings owned and/or used by the city. Finally, the committee shall have jurisdiction for the purpose of investigation and reporting to the city council all matters pertaining to the beautification of public spaces and city property.

St. Louis County Executive Dr. Sam Page signed an executive order Wednesday, March 18, 2020 restricting public gatherings to fewer than 10 people as part of the ongoing efforts to prevent the spread of coronavirus.

Therefore, one or more of the members of these committees will be participating by telephone or other electronic means. Members of the public will not be allowed to attend the meeting in person.
